With a Benefit Assistant in your corner, the claims process is easier

If you're a member with a supplemental health plan—like Accident, Critical Illness or Hospital Indemnity—it's good to know you've got Benefit Assist looking out for you. The service, included at no additional cost, is designed to help make sure you get the benefits you're eligible for—and get them easier. **Here's how Benefit Assist does the heavy lifting for you:**



Reviewing

A Benefit Assistant will review your eligible medical claims



Supporting

If any of your medical claims appear to qualify for a benefit payout from your supplemental health plan, you will receive a call*



Connecting

You'll be connected with a claims specialist who will help you submit a supplemental health plan claim on your behalf, so you can get your benefit payout

Automatic payments

Some claims, such as those for Wellness and Hospital Indemnity, may be paid automatically. In those cases, the eligible medical event is identified, and a check is mailed to you without the need to file a claim or be contacted by a Benefit Assistant.

There's no obligation to use Benefit Assist to file your supplemental health plan claim. You have the option to submit your own claim by visiting the member portal at **myuhcfp.com** or calling **1-866-556-8298**.
